All international applicants that require either an F-1 or J-1 visa for entry to the United States must verify finances. This is not used to determine academic qualification for admission but must be satisfactorily documented for the issuance of the Forms I-20 or DS-2019 that are used to obtain a student visa through the U.S. Consulate.

Applicants must submit a certified original bank statement indicating that sufficient funds are available for at least the first year. If the bank statement is not your own, the sponsor must complete the SRU Financial support statement. Personal bank letters/Affidavits are NOT acceptable. Below are the estimated costs by graduate program.

Graduate students are not required to live on campus but have the option. For purposes of estimating room & meals for immigration purposes the average on campus cost is used.
