ABOUT THE PROGRAM

The Clinical Mental Health Counseling (CMHC) M.A. Program prepares graduates to thrive in rewarding and in-demand careers in the counseling field. Our 60-credit program is CACREP-accredited and fulfills the education requirements to sit for the National Counseling Exam (NCE). Our curriculum aligns with the academic requirements for professional licensing in Pennsylvania and includes closely supervised clinical fieldwork. Students train with faculty who are experienced counseling professionals and benefit from small class sizes, attentive advising, and opportunities for professional development. Our graduates are empowered and equipped to be advocates and agents of change in meeting the mental health and wellness needs of a diverse, global community.

PROGRAM HIGHLIGHTS

Mental Health Counselor employment opportunities are projected to grow 22% from 2021 to 2031, much faster than the average for all occupations

- Our students achieved a 100% Pass Rate on National Counseling Exam (Spring 2022)

ABOUT THE DEPARTMENT

The Department of Counseling & Development is housed in the College of Education and provides outreach and other valuable services to the University-at-large. Faculty teach in their respective areas of expertise and/or provide counseling services through the University's Student Counseling Center. The department offers both degree and non-degree programs in Clinical Mental Health Counseling and School Counseling, and degrees in Student Affairs in Higher Education and College Counseling. The Department's on-site facilities include a state of the art counseling & observation lab and the University's Student Counseling Center.

PROGRAM OPTIONS

The CACREP-Accredited CMHC M.A. (60 cr.) program curriculum is delivered through on and off-campus experiences with full and part-time options. The full-time plan of study generally requires 2 years of coursework and a 3rd year of supervised, clinical fieldwork.

- Current SRU students enrolled in SRU's Psychology undergraduate programs may apply to the accelerated 3+3 Program which requires 3 undergraduate and 3 graduate years of study
- The Department of Counseling & Development also offers a Counseling Endorsement option designed for individuals holding a master's degree in counseling or a counseling-related field seeking additional coursework to meet licensure or certification requirements

ACCREDITATION, CERTIFICATION, & LICENSURE

The Clinical Mental Health Counseling M.A. program at SRU is accredited by the **Council for Accreditation of Counseling and Related Education Programs (CACREP)**. CACREP accreditation assures the content and quality of the program, as well as the program's professional and financial health has been evaluated and meets standards set by the profession. Some states require graduation from a CACREP-accredited program to be eligible for licensure as a professional counselor. Graduates of the Clinical Mental Health Counseling M.A. Program meet the academic requirements for Pennsylvania licensure in professional counseling (LPC) and for the NCC, the National Certified Counselor credential through NBCC. Only state and national boards can award professional licenses and certification and applicants are encouraged to contact such boards for the most recent requirements and information.

ADMISSION REQUIREMENTS

Applicants must submit the following materials along with a completed online graduate application and non-refundable application fee:

1. Official undergraduate degree transcript(s) and any graduate transcripts.
2. A minimum undergraduate grade point average of 3.0 to be considered for unconditional admission.
3. A personal statement indicating interest in the program, experience, and career goals.
4. Two electronic recommendation forms from former or current college or university faculty or recent employer/supervisor with knowledge of the applicant's academic aptitude, suitability for intended program area, and ability to form interpersonal relationships.

Applications are reviewed year-round and interviews are required.
