# Slippery Rock University of Pennsylvania Council of Trustees

## RESOLUTION

WHEREAS: The Pennsylvania State System of Higher Education Board of Governors (Board) has statutory authority to set tuition for Pennsylvania's State System of Higher Education (State System); and

WHEREAS: Policy 1999-02-A: Tuition provides guidelines for System universities to recommend multiyear university tuition strategies for approval by the Board; and

WHEREAS: Such strategies must minimize financial barriers to student access and success and must serve the needs and best interest of the university and the System; and

WHEREAS: The President, in concert with the Council of Trustees, and upon concurrence of the Chancellor, shall recommend comprehensive tuition pricing strategies for Slippery Rock University to the Board for approval; and

**WHEREAS:** At its December 10, 2021 meeting, the Slippery Rock University Council of Trustees acted upon the recommendation of the Slippery Rock University administration to increase tuition by two percent for FY 2022-23 for Undergraduate, Graduate, In-State and Out-of-State students, and

**WHEREAS:** the recommendation was forwarded to the Board of Governors to approve the University's tuition plan, and

WHEREAS: Given the recent action by Governor Tom Wolf and the General Assembly providing the Pennsylvania State System of Higher Education institutions additional funding as part of the Fiscal Year 2022-23 state budget, it is the recommendation of The Slippery Rock University Council of Trustees in concert with the University administration to rescind the motion that was passed on December 10, 2021,

**THEREFORE, BE IT RESOLVED,** The Council of Trustees of Slippery Rock University rescinds its call to action of December 10, 2021 regarding tuition.
