#### REPORT OF THE PRESIDENT

<u>Welcome Back Video:</u> As is customary we shared a couple of videos with the campus. We are excited to share two videos that were shared this year.

Enrollment: Enrollment has increased 2.6% compared to last year. There were 8646 students enrolled as of September 5<sup>th</sup>, which is 221 more students compared to the same day last year. This is the largest year over year gain since 2016, which was a very different environment in higher education. These numbers are subject to change as Pennsylvania's State System of Higher Education will verify and report enrollments by Oct. 4. Census data for each school is taken on the 15th day of the semester for national and state reporting purposes. There was notably an increase in transfer students which is reflective of some significant changes made by Enrollment Management. We had an increase in newly enrolled graduate students but a decline overall. Although not all of the data is in, the decrease appears to be within the College of Health Professions and in the MBA program. Both deans have been alerted to the issue, and we will be working to turn the trend around. The overall increases in UG retention have exceeded the five-year targets within the SRU Strategic Plan, and as such we are continuing to strive for incremental increases.

<u>Financial Picture/Budget Scenarios:</u> The unaudited bottom line for E&G for FY 2024-25 is \$1.6M. At the end of the fiscal year, there were positive balances of \$136K in self-support funds and \$435K in Other Fee Fund categories that retain their balances. These funds include (STEM-H fees, Music Fees, PA and OT fees, Engineering Program Fees). We ended with a positive \$493K in Health Services which was used to help offset its negative \$1M fund balance. (Please see structured for success for additional information on Health Services.) SRU was able to make significant transfers to reserves for long-term projects, including the proposed academic masterplan implementation, lifecycle plant reserves, network technology upgrades, and the police station

renovation. These were the result of spring tuition exceeding the budget and the continuation of higher interest rates. SRU also received \$915K to cover the healthcare overage from the previous fiscal year. It is important to note that SRU currently uses one-time revenue for one-time expenses and is not using these funds to cover recurring expenses. The CPP was submitted to PASSHE on May 21, 2025, and will be resubmitted on September 29, 2025, with updated data. We do not have a finalized budget as we do not have any information on the amount of the state appropriation.

The PASSHE system has created a four-factor system for assessing financial sustainability. The graphic below illustrates the financial sustainability and health of the university and provides the information for the other PASSHE schools. SRU meets or exceeds all of the metrics resulting in an "all green" rating. Although the financial situation of the University remains positive, we continue to move forward with an eye towards the future and an invest vs spend approach.

<u>Construction and Technology Projects</u>: The summary of construction projects reflects activities within Pillar #2, addressing initiatives designed to enhance the quality, functionality, and aesthetic appeal of campus environment, and to provide state of the art facilities and technology. Extensive information was provided during the June 2025 meeting and as such completed projects are being provided in a list format.

- MacFarland Recreation Sports Complex: The turf project for the intramural fields at the MacFarland Recreation Sports Complex began in May 2025 and will be completed on September 2nd.
- The East West Pond: The pond was dredged.
- Residential Suites: Heat pumps were replaced in buildings A and D, with additional replacements in building F.
- Rhodes conversion back to residential rooms was completed.
- North Hall masonry and façade restoration was completed.
- RM Smith Student Center: The refresh of the Starbucks in the Smith Student Center was completed this summer.
- Mihalik-Thompson Stadium Complex: The new sound system for the Mihalik-Thompson Stadium Complex was completed.
- Boozel Dining hall condensate line was replaced.
- Weisenfluh received an HVAC upgrade.

- ATS Building: Phase two for the DI water upgrade was completed.
- Projects in the Art 1 Building include an ADA entry renovation were started in late August and will be completed in October as well as some scheduled roof repair during a similar time frame.
- Bailey Library began roof repairs in August, and the Math Lab renovation was completed in August.
- McKay and Swope ventilation systems replaced.
- Vincent Science Hall: completed Phase 2 of the Growth Chambers Lab.
- North Road between the stadium and the residential suites was repaved.
- Sidewalks: Based on our ADA audit, approximately \$750k worth of sidewalk projects were completed. We still have several areas of concern. We have submitted a \$1.6M joint grant with the Slippery Rock Borough to PennDOT for additional sidewalk repairs.
- Conversion from Banner to OneSIS 98% complete
- Technology Support Service relocated to Bailey Library
- Windows 11 migration is 90% complete
- Replaced 330 computers in classrooms and academic labs
- Classroom AV technology upgrades in 12 Spotts classrooms
- Replaced 120 faculty and staff computers
- New firewall deployment over Fall break
- Smith Center, Boozel and Weisenfluh have had 76 new wireless Access Points deployed; 257 more to be deployed across campus

Strategic Plan: The Strategic Plan is in its implementation phase. There was good progress during the summer, primarily in Pillar #2 with the construction and upgrade initiatives. The Pillar Co-Chairs will be meeting with Cabinet in the next couple of weeks to propose their goals and activities for the 25-26AY. Many of the activities, outcomes and documents of evidence were shared with the COT by cabinet members.

# Pillar #1 Commitment to a Robust, Supportive, and Inclusive Culture

The structure of the Climate and Culture Office is taking shape and should be finalized this semester. A small work group has been formed and will respond to several options for the location and the structure of the office. The You Rock program has assumed a digital format for increased usage.

# Pillar #2 Commitment to Academic Discovery and Human Growth

The provost provided the COT with an overview of a draft of the Academic Master Plan during a workshop. This plan is currently being shared broadly across the campus. Feedback is being solicited, and the final plan will be advanced. The third arm of the academic enterprise is making progress on corporate partnerships and certificate programs.

Providing faculty with the appropriate resources to advance their scholarship and creative works is crucial to the success of the university. With those additional resources and support it is important to set high expectations and to institute accountability across all ranks. Individual faculty productivity is very important to the health of the collective faculty, the health of the university, and by extension the student experience. We had a strong year but there were declines in some key areas. We will continue to work with the faculty to ensure that they have the resources and support to advance their scholarship and creative works. We added a key area for SRU within scholarship and that is Faculty Sponsored Student Research Presentations. As a school that is dedicated to student growth, this is an important activity to measure and to promote.

# Improve retention and graduation rates.

The stated goal for retention within the Strategic Plan was an increase of .5% year over year for the next five years. This year's performance illustrates a 2.2% gain in one year. This is extraordinary and a result of a multipronged approach to increased retention. It is important to note that this is on top of record setting retention numbers achieved last year. An 86.4% retention rate is a record for SRU as is the persistence rate for Sophomore's to Juniors at 78.0%. The current levels of persistence across cohorts have outpaced the targeted annual improvement of .5% and as such we continue to strive for continued improvement. # Pillar #3 Commitment to Community Impact and Collaboration

# Expand educational learning and growth opportunities that add value to external constituencies.

The community engagement teams designed a community engagement plan which has been submitted to Carnegie. This classification project will provide a roadmap for future engagement within the community. With the new staff in University Advancement – Alumni Relations we have created a long-term alumni engagement plan. This too will serve as a road map for future engagement, which is a very high priority for the campus and the success of the Comprehensive Campaign.

# Pillar #4 Commitment to Financial Sustainability and Resource Stewardship

The pond project, although partially completed for aesthetic and safety reasons, was also a sustainability project. One of our faculty will be completing a short technical report on the environmental impact of the project, which will be shared with the COT upon completion.

# Ensure alignment and efficiency between and within the affiliated entities.

The group is working to explore how each entity will support the comprehensive campaign and is turning its attention to action versus sharing of information. The group has also been working with Ken Bach to determine how we can elevate the reputation of the university through social and earned media. The cadence of the meetings will move to quarterly in order to be respectful of the time commitments of those on multiple committees.

# Diversify revenue streams.

In FY25, SRU faculty and staff submitted 43 grant proposals. Out of the 43 proposals submitted, 23 were funded, 11 were not funded, and 9 are still pending funding. Four grant proposals submitted in FY24 were also funded in FY25 for a total of 27 proposals funded. Out of the 27 proposals funded, 7 were Federal (\$243,255); 4 were state (\$1,031,881); 7 were private/other (\$106,629); and 9 were PASSHE Flow Through (\$82,324). Total amount funded in FY25 was \$1,464,089, which is a 6% increase from FY24's total of \$1,373,600.

We have engaged the support of Faith Collins and Jennifer Lasser from the Southwestern Pennsylvania Commission, to provide technical assistance for state and federal grant programs. They have also helped us to identify possible funding sources for all aspects of the university.

#### **Presidential Activities**

During the past several months I have continued to serve in my role as a member of both the Rural Revitalization Commission as well as the Pennsylvania Ireland Trade Commission. I will be representing the Commission in Ireland in a few months. We have two students and a faculty advisor who will also be members of this travel delegation. I have been an invited speaker at the Butler County Chamber of Commerce Women's Alliance Meeting. I have also agreed to serve as a Presidential mentor to a new president who was a part of the AGB Leadership Institute and to an emerging Athletic Director through the NCAA.

### Niche names SRU a 2026 Top Public University in PA

SRU is ranked second in Pennsylvania's State System of Higher Education and sixth among public schools in Pennsylvania, according to the 2026 rankings on Niche, a research company that produces an annual ranking of colleges and universities.

# Apprenticeship program at SRU providing solution for teacher shortage

As leader in teacher preparation in Pennsylvania, SRU is launching a first-of-its-kind teacher apprenticeship program to address the state's critical teacher shortage. Funded by a transformative \$600,000 state grant, SRU's new two-year apprenticeship program will pave the way for professionals working at five local school districts with personal support and \$15,000 in tuition to help them earn full teacher certification and a master's degree.

# SRU adds new 1+2+1 nursing pathway to help address RN shortage

Pennsylvania is facing a critical shortage of nurses, with recent reported vacancy rates of 30% for registered nurses who provide direct care and an anticipated shortfall of more than 20,000 RNs in the state by 2026 is among the highest in the nation. SRU is helping provide an immediate solution at the lowest possible cost to future nurses by introducing a new nursing degree pathway.

# **SRU earns NCAE-Cyber Defense designation**

As an institution at the forefront of preparing professionals to enter the highly skilled cybersecurity workforce, SRU has been recognized as a leader and higher education contributor for cyber defense by a government agency.

# SRU starting 3+2 Master of Public Health pathway

SRU is fast-tracking careers in public health to meet the pace and demand for health care jobs in the region. In response to the 10% growth expected between 2020-30 in public health-related occupations within 150 miles of campus and overall increase in demand for public health professionals, SRU is launching a new accelerated degree pathway. Starting in Fall 2026, students at SRU can earn their Bachelor of Science in Public Health and a Master of Public Health in one of two concentrations in just five years with a 3+2 pathway.

# Academic and Student Affairs Committee (TAB 2 Appendix D)

Dr. Alfonso (Butch) Angelucci chairs the Academic Affairs Committee. The committee met at 2:15 p.m. on September 18, 2025. Trustee Angelucci shared the following report.

Dr. Zieg recapped the Academic Master Plan considerations and needs from last month's workshop. Dr. Tim Slekar, SRU's new Associate Provost for Academic Innovation, discussed an innovative partnership with the Eastern Atlantic States Carpenters and the Master Builders' Association, highlighting the creation of stackable, credit-bearing credentials that lead to a bachelor's degree and are responsive to regional workforce needs. He also provided updates on SRU's concurrent aviation partnership with CCBC, the upcoming Coaching and Refereeing Certificate program, and an emerging AI workforce collaboration with BC3.

Mike May provided updated Fall 2025 enrollment and retention numbers. All three new student populations increased for Fall 2025 and the overall headcount at SRU represents the largest one-year increase since 2016. Retention figures set school records for the second consecutive year.

Ken Bach updated the council on the successful conclusion of the brand research, noting that the brand strategy was presented to the Administrative Council and will soon be shared with faculty, staff, SGA, and COT. Summer success metrics included a large and small screen broadcast campaign targeting confirmed and prospective student households, a 300% year-over-year increase in reach on Instagram, and 2,085 "conversions" of web browsers on a new homepage Open House promotion. A revised program finder that leans into the stories of students, faculty, and alumni will launch in September along with a new navigational architecture to surface important information with minimal clicks.

Dr. David Wilmes provided an update on the start of the semester regarding housing occupancy and student involvement. He also shared new Student Affairs initiatives for the year including: a partnership between Rock Pantry and the Greater Pittsburgh Food Bank, the launch of the Strategic Internationalization committee, and renovations to the MacFarland Recreation Complex and Rhoads Hall.

Madam Chair, this concludes my report.

# Finance and Administrative Affairs Committee (TAB 3 Appendix E)

Mr. Jeffrey Smith chairs the Finance and Administrative Affairs Committee. The committee met at 3:30 p.m. on

September 18, 2025, with Domenic Ionta and Jeffrey Smith in attendance. Smith announced that it would be his last meeting as chair of the committee and that Dan Lavallee would be the chair for the remainder of the academic year.

Carrie Birckbichler, VP of Finance and Administration, provided a financial update for 2025. For academic year 2025, the University's general fund revenues exceeded expenditures by nearly \$1.6 million dollars. However, the Auxiliary budget showed that expenses exceeded revenues by slightly more than \$500,000. Because the Commonwealth has not approved its 2025/2026 budget, the COT was unable to approve a budget for the University. Carrie did provide a draft budget that the COT will vote on once the Commonwealth completes its budget and the University's funding is finalized.

Carrie also shared the PASSHE Financial Sustainability Metrics and Assessment scores for Slippery Rock University. Slippery Rock was one of only two universities that was green, the best rating, in all categories. Looking back over the past five years, no other university in the PASSHE system has performed as well as Slippery Rock University in these metrics.

The meeting adjourned at approximately 4:15 p.m.

# Governance Committee (TAB 4 Appendix F)

Dr. Elise Michaux chars the Governance committee. The Governance Committee met September 18, 2025, at 4:30 p.m. There was one discussion item and one action item. An additional discussion item was added per Trustee Jeff Smith's request.

There was a request to include Trustees in the University's Emeriti designation policy. Committee members heard from President Riley who shared that University Cabinet approved including Trustees for Emeriti designation. Dr. Riley added that we are finalizing the policy and, in particular, the retention of SRU email addresses for emeriti designation in accordance with IT protocols.

The policy will move forward for Governance Committee consideration at the December quarterly business meeting.

Trustee Smith shared his concerns about the PACT organization, its structure, the handling of membership dues, and the lack of professional development/training provided to trustees. Following discussion, it was decided that Trustee Smith will draft two letters: one letter addressed to the PACT President and a second letter addressed to the PASSHE Chancellor. The full Council will review the letters and determine how best to proceed.

There was one action item for Governance Committee review: Certifying Resolution: Order of Succession in accordance with PASSHE (BOG Policy 1983-14-A). The Resolution appoints a succession of SRU executive leaders to serve as Presidential designee on an interim or acting basis, should the need arise. The item was approved to move forward for full Council consideration and action at the business meeting.

With no further business, the committee meeting adjourned. Madam Chair this concludes my report.

# University Advancement Committee (TAB 5 Appendix G)

Joshua Young chairs the University Advancement Committee. The Committee met this morning at 9:45 a.m.

Comprehensive Campaign Co-Chairs, Tony and Regina Robinson provided the trustees with an update on the activity of the Cabinet. They described how they recruited the cabinet and explained how they still plan on recruiting at least three additional members. In addition, they discussed how pleased they are with the diversity of the cabinet including members for the University affiliate groups, faculty and staff, alumni, and a student.

The Robinson's updated Council on the monthly meetings and talked about how the Cabinet worked on getting to know one another before concentrating on finalizing both the duration of the campaign and the campaign goal, updating the case for support, reviewing the campaign budget, and investigating the gift table. They spoke about men's wrestling and women's wrestling being included in the case for support, and about other items being removed.

Tony and Regina then updated the Council on the progress of the campaign. As of the end of August, with 31% of the campaign complete, 58% of the total goal has been raised. Prior to the campaign, the University was raising between \$2-\$3 million annually, and in the first two years of the campaign, over \$17 million has been raised. Case statement goals were revealed, and the scholarship goal has already been met. Finally, 33% of the campaign total currently comes from estate gifts. As there are immediate advancement needs, it is important to keep this percentage under 40 percent. This threshold has been met thus far.

Finally, the co-chairs explained the next steps for the campaign cabinet. They will approve a campaign budget when the Commonwealth budget is finalized; will begin creating and implementing a marketing plan prior to the public launch scheduled for 2028; will continue to work on the gift table; and will continue to review the campaign case for support. In addition, Tony and Regina announced the 25-26 Advancement goals: 1. Raise \$5 million in the fiscal year, 2. Reach 70% of the total campaign goal in the fiscal year; and 3. Finalize the advancement and university event process.

Troy Miller then updated the Council on naming resolution for Messer Park at Critchfield Park.

Tim Richart, Senior Director of Annual Giving and Alumni Engagement, provided an update on the 5-Year Alumni Engagement Plan. He discussed the value proposition, priorities, and goals of the plan, and reminded the Council about how the Alumni Association benchmarks results. Tim went through the metrics, provided an update on A Vintage Homecoming, and provided an overall list of upcoming events.

Dave Hollenbaugh, the Executive Director of the SRU Foundation, provided an update on the Foundation with a concentration on financials, scholarships, and all Foundation activities.

Foundation assets increased to over \$57 Million with \$290,000 of total liabilities. The Foundation asset allocation continues to remain within the guidelines of the Foundation Investment Plan. In addition, total scholarship support over the 24/25 fiscal year was over \$3 million dollars. Dave then updated the Council on the SRUF Student Housing, LLC Balance Sheet.

Finally, Dave provided the Council on additional Foundation activities including approving and implementing an updated endowment administration process, working with the University for long-term capital projects related to the Residential Suites, and finding the next productive project for Technology Park.
