

Current Student Housing Application Instructions

Housing Agreement Overview

LLC Info: <https://www.sru.edu/life-at-sru/housing/living-learning-communities>

Indicate your Living Learning Community (LLC) preference. LLCs are organized by academic college and allow students to live with peers in their major.

Indicate your preferred housing area: Residential Suites (Buildings A–F, Watson) or Traditional Halls (North, Rhoads). Preferences are not guaranteed; LLC preference takes priority.

All residence halls are mixed-class years. Assignments are not based on race, color, sexual orientation, or creed. Gender-inclusive housing is available upon request. (Rates and Fees: <https://www.sru.edu/life-at-sru/housing/rates-and-fees>)

Review estimated room rates and fees. Final pricing for 2026–2027 will be confirmed later in the summer.

On-campus residents are automatically assigned a standard meal plan, which can be changed beginning in July and into the first two weeks of the semester.

Before You Begin

Have a credit card or banking information ready for the \$175 non-refundable housing fee.

Provide your meningitis vaccination date or complete the online waiver.

Contact the Housing Office if you cannot pay the fee due to financial constraints.

Application Steps

Step 1: Sign the Housing Agreement

Log into MyHousing Portal: <https://reslife.sru.edu>.

Select “Application/Agreement” and choose the Fall agreement.

Read the agreement carefully; it is a legally binding contract for the academic year.

Sign electronically and click “Continue.”

Note: Students must have a meal plan. Changes can be made after July 1 via MyHousing.

Step 2: Complete “My Information”

Medical housing requests require registration with the Office of Disability Services.

Provide meningococcal vaccination date or waive online.

Indicate housing preference areas of either TRADITIONAL or RESIDENTIAL and LLC preferences. Honors LLC requests require both roommates to apply and be approved. For all other LLC requests, you can locate an intended roommate with a different LLC option or non-LLC option than your own chosen LLC options

Step 3: Pay Housing Deposit

Submit the \$175 fee to finalize your application. Without this deposit, your application will not be processed.

Step 4: Roommate Selection

Roommate requests open Feb. 3-28. Requests must be mutual and limited to five (5) students.

If you cannot locate your intended roommates, you need to check if they have been admitted, paid their enrollment fee, completed their housing application, applied to Honors and are awaiting Honors LLC approval, is a first year or transfer student (contact Housing and Res Life), or is a different gender (contact Housing & Res Life)

Use the "Roommate Wanted Ad" feature in MyHousing if needed.

Step 5: Room Selection – February

You will receive an email to your SRU account before this step begins.

Upper-class students who complete the application and pay by Jan. 31 may select rooms in February.

If students have not selected their roommate(s) yet, they can do so in February as well.
