

2025-2026 Room Selection Information for RETURNING/CURRENT STUDENTS



<p>December 2, 2024 Opens 12:30PM</p>	<p>The 2025-2026 On-Campus Housing Agreement Opens for current/returning students that are required to reside on-campus as outlined in the 2-year residency requirement. As part of this agreement, students will pay a non-refundable \$175.00 deposit. For information, please visit: https://www.sru.edu/life-at-sru/housing/residence-requirement</p> <p>Students required to reside on campus will have a Fall 2025-Spring 2026 Agreement to complete under Applications on their MyHousing portal.</p> <p><u>INCOMING TRANSFERS:</u> Incoming transfers are NOT required to reside on campus, and are NOT required to sign an on-campus agreement or complete an exemption to live off campus.</p> <p><u>EXEMPTION FROM RESIDENCY REQUIREMENT (Opens Dec 2):</u> Students that are required to reside on-campus but wish to seek an exemption from the requirement should FIRST complete an exemption request. Reasons for exemption include, but not limited to: will be over 21 years old, will have 48 credits, commuting from permanent home address, etc. Any supporting documentation can be uploaded as part of the request. An approval/denial decision will be emailed via your SRU email within 3 weeks of exemption request.</p> <p><u>ON CAMPUS PLACEMENT REQUEST (Opens Dec 2):</u> Those upper-class students (rising Juniors and Seniors) that are not required to reside on campus will not see an agreement in their portal on Dec 2, but can choose to sign the On-Campus Placement request to indicate they would like the potentially be offered an on-campus agreement should our office determine space permits. Students can note their reasons for review. If an on-campus agreement can be offered, that will come via SRU email (with a deadline to sign by) on a rolling basis in order of request. We cannot guarantee the ability to offer upper-class students an on-campus agreement, but will do our very best!</p>
<p>January 31, 2025 By 11:59 PM</p>	<p>Signed agreements and \$175.00 deposit (and LLC application if applicable) are due in order to participate in the online selection process. Students can still sign up after January 31, but will not be part of self-selection, but instead will be assigned; after January 31, students can still match with roommates to then be assigned by our staff.</p>
<p>February 3-28 Common hour (12:30p)</p>	<p>Roommate Selections (roommate matching) for all students with completed on-campus agreement. Students can select up to 5 other roommates for a maximum group of 6 total. (Examples: A matched group of 6 would be able to select an available Triple Suite, a matched group of three could select from available Triple Studio or Traditional Triple, a matched group of 4 could choose from available 4 Single Suites or Double Suites). This is for LLC and non-LLC. February 3: LLC acceptance notifications will be available on your MyHousing portal. If your major matches LLC Requirements this will be an automatic approval. Honors and Rock Athletics must be approved by those areas via our staff.</p>

Thursday, Feb 6 Common hour (12:30p)	LLC Room Selections begin at common hour on February 6. You must have roommate requests fully matched. You will only see rooms available in the building/floors your LLC is located. LLC groups of 2 or 3 people who want a four-person room will select their potential room starting February 14.
Tuesday, Feb 11 Common hour (12:30p)	Four-person and six-person room selections for Non-LLC begin at 12:30 pm. You must have your roommate requests fully matched.
Thursday, Feb 13 Common hour (12:30p)	Two-person and three-person room selections for Non-LLC begin at 12:30 pm. You must have your roommate request fully matched.
February 14-28	Any student who completed an agreement and paid deposit by January 31 but did not yet choose a room/roommate(s) can select a bed on their own starting 12:30PM February 14 both for Non-LLC and LLC.
Room Selection Time	We use a lottery type system to determine a specific time a student selects. We will take the collective time of when you (and matched roommates) submit the completed application and deposit. You will then be assigned a priority number and time. The earlier your priority number the earlier you will select. Students will be able to see their specific lottery time after 9am on the day of your specific room selection.
LLC Notes:	<p><u>Living Learning Community Locations:</u> Building A - Health Engineering and Science (and Health professionals) Building B (Select Floors) - Rock Athletics and Business Watson Hall - Education and Honors Building D (Select Floors) – Liberal Arts</p> <p>If you wish to CANCEL an LLC selection, you need to do so before your selection date. In your My Housing Portal select "View My Housing Application" to cancel.</p> <p>If you wish to ADD an LLC you can log into your MyHousing portal and select "Returning Student App," then use the drop down to select/update. This must update to our system overnight, so it will not be immediate.</p>

This means any annual % increase will not be applied for your second year.</p> <p><u>ROOM CHANGE REQUEST OPEN MARCH 3:</u> After you have an assignment, if you would like to request a different building or room style, you can fill out an "Alternate Room Request" on the MyHousing portal; any/all roommates should fill this out to have a matched request. These room change requests will be monitored and adjusted up through August 1. We cannot guarantee availability of the room you desire.</p>
