- If you will be a transient student at another PA State System of Higher Education university and wish to transfer both the credits and the grade, complete the PASSHE Visiting Student form.
- Grades earned at other institutions will not be used in SRU GPA calculation.
- To graduate from SRU with honors, students must complete a minimum of 45 credits in residence at SRU.
- Return this completed form with required signatures to the office of Academic Records and Registration.

Undergraduate Transient Clearance Form

Requirements: (Dean’s signature is required below to waive any of the following)

1. Courses in which a grade was earned at SRU may not be repeated at another institution.
2. 30 of the last 60 hours of credit prior to graduation must be earned at SRU.
3. Transfer credit can only be awarded for courses in which a grade of “D-“ or better was earned
4. Undergraduate students who are suspended from SRU and all post baccalaureate students must have their Dean’s signature to be a transient student
5. Credit by exam is not acceptable in transfer if taken as a transient student.
